

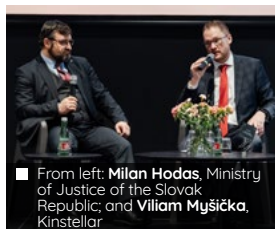
4TH ANNUAL RESTRUCTURING DAY

April 9 | 2025

The fourth edition of Restructuring Day reaffirmed the critical role of insolvency law in strengthening the Slovak business environment. Amid ongoing economic challenges, the event spotlighted the urgent need for effective restructuring tools and legal clarity. With a full house and high engagement, the interest of the business community in this topic was obvious. The event featured three expert panels covering the legal and economic aspects of selling a business in insolvency, the relevance of foreign trust funds to Slovakia,

and the most pressing challenges in the country's insolvency framework. Discussions blended legal and economic insights with real-life case studies from Slovakia and abroad, offering participants practical and strategic perspectives.

This year's program once again emphasized the importance of open dialogue among stakeholders, from legal experts to financial professionals, to improve Slovakia's insolvency processes and ensure business resilience.



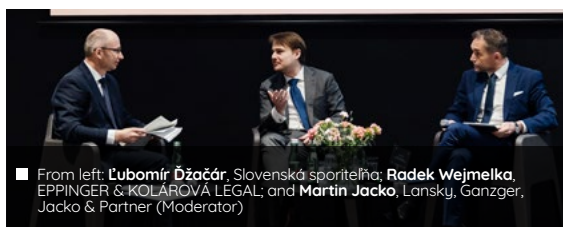
