Preparing a data-driven competitiveness agenda so that political leaders enter the 2027 elections with clear, concrete recommendations on their table.

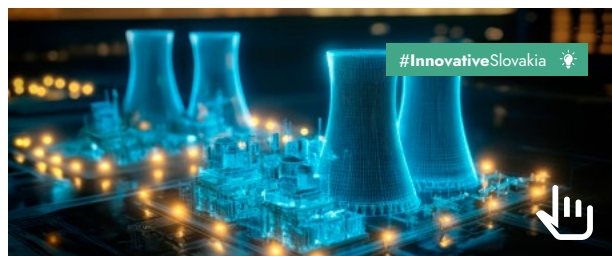
