MOBILE PRICES

INDUSTRY

Slovakia's industrial production continued falling for the fifth consecutive month. In December 2019, it fell by 7.1 percent year-on-year, affected mostly by the drop in manufacturing by 8.5 percent, the drop in electricity, gas, steam and air-conditioning supply by 1.9 percent, and the rise in mining and quarrying by 9.7 percent.

Economists evaluate wage costs, labor productivity as well as investments in R&D. ECONOMY

The growth of Slovakia's economy came as a positive surprise to analysts. The gross domestic product at constant prices increased in the final quarter of 2019 by 2.1 percent year-on-year. After seasonal adjustment, GDP rose by 1.9 percent y-o-y and 0.6 percent compared to the previous quarter.

PRICES

Consumer prices in Slovakia went up at the start of 2020 again, with only food products getting costlier at a slower pace. In January 2020, year-on-year inflation rate reached 3 percent in total, and consumer prices increased by 1.2 percent compared to December 2019, the Statistics Office (ŠÚ SR) informed.

UNEMPLOYMENT

Unemployment went up slightly in January, stopping at 4.98 percent. Although more seasonal workers, mostly from the construction industry, usually come to labor offices at the start of the year to be registered as unemployed, their number was lower this January than in the past. Labor offices registered 13.2 percent, or 2,900, less jobless people compared to last year.

ECONOMIC GROWTH

Slovakia is losing its economic battle after a decade of strong post-crisis economic growth. The European Commission (EC), which recently published a report assessing Slovakia's progress on structural reforms and the prevention of macroeconomic imbalances, said the country did not fully make use of favorable economic times and has failed to sufficiently implement reforms, reduce its deficit and debt, and improve in areas key to economic growth, including R&D, education, and innovation.

ELECTIONS

A record number of Slovaks living abroad decided to return home before the February 29 elections. The number of Slovaks who booked a flight for the February 29-March 1 weekend is 133 percent higher compared to the 2016 period, when the last parliamentary elections took place, the statistics of the Pelikán travel agency show. The company took into account airports in Vienna, Bratislava, Budapest, and Košice.

ELECTIONS

The OLaNO Opposition party of Igor Matovic won the general election on February 29th on 25.02 percent of the votes, gaining 53 seats in the 150-member House, ahead of the current main governing party Smer-SD on 18.29 percent (38 seats). Other seats in Parliament will be taken up by We Are Family (8.24 percent – 17 seats), the far-right People's Party Our Slovakia (7.97 percent – 17 seats), Freedom and Solidarity (6.22 percent – 13 seats) and For the People (5.77 percent – 12 seats).

EUROPE & WORLD

WORLD POLITICS: The EU on February 4th strongly condemned the decision by US President Donald Trump to lift US restrictions on the usage of landmines. "Their use anywhere, at any time and by any actor remains totally unacceptable to the European Union", the EU's diplomatic chief Josep Borrell said in a statement.

MIGRATION: A new law providing a special registry for all non-governmental organizations (NGOs), their employees and partners, was voted on February 4th. It is supposed to help the government regulate and control who takes part in migration crisis management, as well as the role it plays. The bill came right after new riots began in Northern Aegean islands, both from citizens and refugees, due to the increased number of migrant flows.

US POLITICS: President Donald Trump was acquitted by the US Senate on February 5th following a historic impeachment trial that shone a harsh light on America's divisions, without ever shaking the loyalty of his voter base. In a political triumph for the US leader, Trump drew on staunch Republican support to easily defeat a Democratic effort to expel him from office for pressuring Ukraine to help bolster his re-election effort.

TRADE: Goods barometer signals further weakening of trade in first quarter of 2020. World merchandise trade growth is likely to remain weak in early 2020, according to the WTO Goods Trade Barometer released on 17 February. The real-time measure of trade trends now reads 95.5 — less than the 96.6 recorded last November and well below the index's baseline value of 100. This below-trend performance could be reduced further by a new global health threat.

ARTIFICIAL INTELLIGENCE: Al technologies carrying a high-risk of abuse that could potentially lead to an erosion of fundamental rights will be subjected to a series of new requirements, the European Commission announced on February 19th. As part of the executive's White paper on AI, a series of 'high-risk' technologies have been earmarked for future oversight, including those in 'critical sectors' and those deemed to be of 'critical use.'

WORLD CLIMATE: Europe's top companies need to more than double their current level of spending on low-carbon projects to meet the European Commission's flagship goal of 'climate neutrality' by 2050, according to a report released on February 25th. The major study of 882 publicly traded companies across multiple sectors by climate research provider CDP and consultancy Oliver Wyman showed they spent €124 billion on capital investment and research and development in 2019.

EUROPEAN COMMISSION: The EU Commission will present this autumn a strategy on an integrated EU payments market, to facilitate the use of national payment services across Europe and reduce the dependency from international card operators such as Visa or Mastercard. The Single Euro Payments Area (SEPA) provides for uniform credit transfers and direct debits for over 500 citizens in the EU.

WTO: At a meeting of the Technical Barriers to Trade Committee on 25-26 February, WTO members discussed how to improve regulatory cooperation on self-driving cars and medical devices. They also exchanged experiences on procedures related to testing and certification. These discussions were followed by a regular meeting of the Committee on 26-27 February, where members discussed 64 trade concerns, 12 of which were new.

EUROPEAN COOPERATION: Twenty-three European countries signed a letter of intent for the Intelligence College in Europe in Zagreb on February 26th, completing the creation of a network of intelligence agencies on the continent. This event was followed by a public discussion on "intelligence cooperation" involving European intelligence community representatives and decision-makers.
